The highlight no doubt was the completion of the strategic plan for the Foundation with an updated theory of change. We have also started an online caregiver support group. Our annual walk which is now virtual continues to improve our reach with the message of dementia.

New partnerships with Foundation of Goodness and CL Synergy have enabled us to conduct further awareness and training and we are as always thankful to everyone who has joined hands to support our cause. Our numerous well-wishers have given generously despite the hard times and we have not been in want to sustain our services free of charge. We thank them all.

LAF is built on volunteerism and our volunteers are our core. They bring in unparalleled value addition to our services, above and beyond what any employee can bring. Seeing is believing and a day at our activity centre will enable one to witness their utmost dedication and commitment to serve those with dementia.

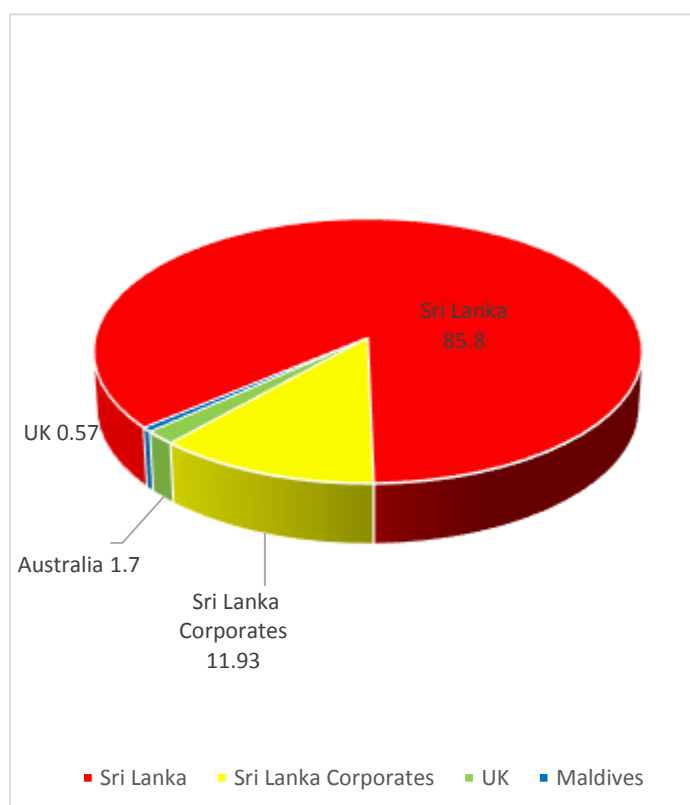

Year in Review 2021 to 2022 –

Awareness programmes

In August 2021, Lanka Alzheimer's Foundation (LAF) undertook a strategic development exercise to review its external and internal processes to improve the quality of life for people with dementia and their caregivers. A strategic plan was formulated for the next five-years: 2022-2026.

LAF believes that local **Dementia Friendly Communities** have the capacity to meet the needs of persons with Dementia, their carers & promote awareness about Dementia and its risk reduction.

With this in mind, we have started the Dementia Friendly Communities initiative as a Pilot project in Galle from January 2022. Mrs. Wasanthi Kumudini, is our new Project Co-ordinator who works in the Gonapinuwala Divisional Secretariat area engaging with Elders societies and helping them support their own elders with dementia. We are happy that we obtained the necessary permission for our work from the District Secretariat in Galle.

The project will envisage

1. Awareness programs on dementia
2. Memory clinics for elders
3. Home visits to support elders with dementia
4. Training of elders to care for people with dementia
5. Carer support groups

Visits were made by Professor Shehan Williams and Beverley Mirando to Galle to meet with the Elder Rights promotion officer and counseling officer, the MOH at Arachchikanda, Dr. Krishanthi Siriwardena who conducts the psychiatric clinics under the supervision of Dr Rumi Ruben, Consultant Psychiatrist and the NGO co-ordinating officer. Meanwhile, awareness programs conducted by Ms. Wasanthi began in different areas within the Gonapinuwala district, at the request of the Elders Societies in the areas.

For the first time, on 16th March, Memory Screening clinics were held at two temples within the Gonapinuwala Divisional secretariat area, conducted by Professor Shehan Williams and two doctors, Drs Rishara and Parami who are both registrars in psychiatry. 26 elders participated in the two clinics from 12 elder societies in the area. People who attended the clinics got advice from doctors how to improve and retain their memory. Follow up work with a selected group of elders will be done to ensure that they visit the Psychiatric Clinic conducted by Dr. Krishanthi Siriwardena.

In the afternoon, a visit to the Foundation of Goodness, Seenigama, Galle, took place. A meeting was organized with the Elders in the area, and Prof Shehan Williams spoke to them on Dementia.

This is the beginning of an exciting journey by LAF to develop Dementia Friendly Communities all over Sri Lanka.

From a Volunteer's perspective

Volunteering amidst the pandemic

The current COVID-19 situation that the world is currently battling, has been an unwelcome interruption in our lives. During the island-wide lockdown last March and the subsequent isolating of the area again in the latter part of the year, the Lanka Alzheimer's Foundation was forced to close its doors to its clients in the interest of everyone's safety. Being indoors for a long period and away from everyone was difficult for all of us. However, our volunteers at LAF knew that this would be especially difficult for the clients who often look forward to their weekly outings to the activity centre. Hence, since the centre was closed, the volunteers went out of their way to still be a part of the client's lives.

The volunteers reached out and kept in touch with the clients regularly via telephone and checking on them. I'm sure both clients and volunteers alike, looked forward to this. Additionally, clients were also sent a monthly activity work sheets, that included engaging tasks like adult colouring, word games, etc. This almost made it feel like the activity centre had come home. The volunteers also wished to ensure our clients were staying active and fit, especially at this time since movement is restricted. So chair yoga videos which were created by one of our very own volunteers, were uploaded to the LAF Facebook page to encourage our clients to move around and exercise in the safety of their homes. With the arrival of the vaccines and enforcement of stricter health regulations, the LAF opened the activity centre on 17th March & welcome our clients back. While ensuring that COVID regulations will be followed in the centre, the volunteers will continue to take that extra step and do what they can for our clients.

“Reduced Sleep is a risk factor of dementia”

If you are trying to get by on about six hours or less of sleep a night during the workweek, you're setting up your brain for future failure, according to a new study .

Sleeping less than six hours a night in middle age can increase your dementia risk, a long-term study has found.

After following nearly 8,000 people for 25 years, the study found a higher dementia risk with a "sleep duration of six hours or less at age 50 and 60" as compared to those who slept seven hours a night.

In addition, persistent short sleep duration between the ages of 50, 60 and 70 was also associated with a "30% increased dementia risk" independent of "sociodemographic, behavioural, cardiometabolic, and mental health factors" including depression, the study said.

"Sleep is important for normal brain function and is also thought to be important for clearing toxic proteins that build up in dementias from the brain," said Tara Spires-Jones, who is deputy director of the Centre for Discovery Brain Sciences at The University of Edinburgh in Scotland, in a statement. Spires-Jones was not involved in the study.

"What is the message for us all? Evidence of sleep disturbance can occur a long time before the onset of other clinical evidence of dementia," said Tom Denning, who heads the Centre for Dementia at the Institute of Mental Health at the University of Nottingham in the UK.

"However, this study cannot establish cause and effect," said Denning, who was not involved in the study. "Maybe it is simply a very early sign of the dementia that is to come, but it is also quite likely that poor sleep is not good for the brain and leaves it vulnerable to neurodegenerative conditions like Alzheimer's disease."

Awareness would enable people to self-monitor for symptoms & stop it in its tracks. Globally millions could face increased or accelerated risk of dementia as a consequence of long-COVID.

LAF is calling on the World Health Organisation (WHO) and governments to **globally prioritise and fund vital research** on links between COVID-19 and dementia.

We urge everyone to follow preventative measures such as a balanced diet, physical activity and challenging brain activity.

All of this would reduce the risk of dementia.

3. Problems with language
4. Disorientation to time and place
5. Problems keeping track of things
6. Changes in mood and behaviour
7. Challenges understanding visual and spatial information
8. Poor or decreased judgement
9. Misplacing things
10. Withdrawal from work or social activities

Memorable Steps 2021 - A Virtual Walk for Alzheimer's

To mark World Alzheimer's Month, LAF once again organized a virtual walk in September. "Memorable Steps 2021" was held from the 10th to the 30th September. The challenge required participants to walk 100,000 steps 'virtually', beginning in Kalutara and ending in the Galle Fort. A separate 'Team challenge' was also introduced this year to enable teams of 5 members to take up the challenge of completing 500,000 steps each. Many teams from corporate organisations joined in the team challenge.

The importance of exercise to improve our physical and mental health amidst the COVID-19 pandemic was the emphasis of the Virtual Walk. Our social media campaign commenced prior to the walk, and an oversubscribed webinar on "Covid, Exercise and Dementia" by the eminent Virologist Prof Neelika Malavige and Prof Shehan Williams was hosted by Daily Mirror online on the evening of 8th September. The video was live streamed and as of now has more than 11000 views on facebook.

Videos of a volunteer and members of her family, our ambassador Johann Pieris and a social media influencer were carried along with important messaging on dementia, its prevention

and early warning signs. Radio messaging about the walk was carried out by Legends and short clips were aired on MTV.

On September 21st, the World Alzheimer's Day, we celebrated the virtual walkers from both the individual and corporate challenge, who had together walked 27,010,085 steps towards raising awareness for Alzheimer's.

The leader board of the Ayubo.app carried updates on the number of steps completed by individual and team walkers. By midnight on 30th September when the challenge ended, 339 individuals & 28 corporate teams had walked 32,996,467 steps; an outstanding feat indeed.

"Memorable Steps 2021" would not have been possible without the partnership of Ayubo.life led by Chandima Cooray, Prashanth Rajaratnam and the team at Digital Healthcare Solutions Pvt Ltd. Rishini Weeraratne and her team from Daily Mirror online and Hi online coordinated the media efforts including interviews and posts on social and the print media. 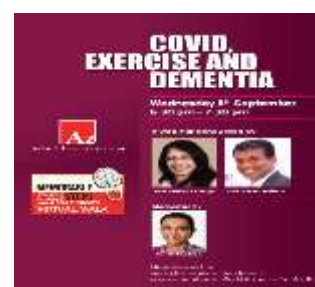
8th September Webinar – COVID, Exercise and Dementia

"Journey through the diagnosis of dementia" - World Alzheimer Report 2021

The above report has found that an estimated 41 million cases of dementia go undiagnosed across the globe. This, combined with new breakthroughs in treatment for diagnosis, could overwhelm unprepared healthcare systems say Lanka Alzheimer's Foundation and Alzheimer's disease International (ADI).

According to the new [World Health Organisation \(WHO\) statistics](#), Dementia is the seventh leading cause of death among all diseases worldwide. Stigma is still a major barrier to diagnosis, and combined with lack of awareness is hampering efforts to support people living with dementia.

Furthermore, the ongoing COVID 19 pandemic has been identified for causing additional delays and wait times for providing diagnosis.

ADI continues to call on Governments worldwide to implement their country National Dementia Action Plan that will enable people with dementia to receive their diagnosis and know what to do next, as dementia is a progressive disease and figures are growing every year.

Treasurer's Report

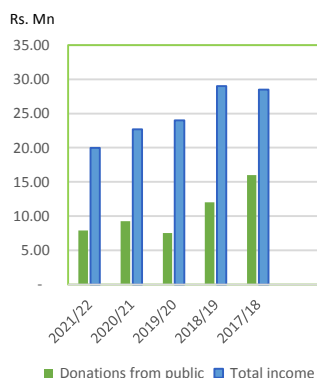
We raised Rs. 7.88Mn. from the public by way of donations during the year 2021/22, which is 14.8% less, compared to the previous year. Income from profit generating activities were also low as the Foundation was not fully functional throughout the year due to the pandemic.

Fixed cost such as salaries, utility and maintenance of premises costs were incurred, although the activity centre did not fully operate during the year. Total expenses incurred during the year 2021/22 was Rs. 9.2 Mn. Compared to Rs. 10.45 Mn. incurred during the previous year.

Interest earned from the sustainable fund was also lower compared to the previous year, due to the low interest rates offered by the financial institutions. Interest earned from the sustainable fund investments were not utilized for any operational expenses and was reinvested. Operational expenses incurred during the year 2021/22, were met from donations received during the year.

We wish to thank all our stakeholders for the support extended and the courage given to us, in numerous ways to carry out operations of the Foundation during the pandemic.







Notes to the Financial Statements

For the year ended 31 March 2022

1. REPORTING ENTITY

1.1 Domicile and legal form

The Lanka Alzheimer's Foundation ("the Company") was incorporated on 23 March 2001 as a Company limited by guarantee, and reregistered under the Companies Act No.07 of 2007 as Guaranteed Limited Liability Company and domiciled in Sri Lanka. Every member of the Foundation has undertaken to contribute an amount not exceeding Rs.100/- in the event of a liquidation of the Foundation.

1.2 Principle activities and nature of operation

The primary objective of the Foundation is to improve the quality of those with Alzheimer's and relate dementia and enhance the wellbeing of their families and carers. The Foundation provides therapeutic activities to persons with dementia and respite for their carers, memory screening and assessments etc. Since the incorporation of Alzheimer's and Related Disorders Foundation of Lanka, there have been many instances where the name was abridged to read "Lanka Alzheimer's Foundation". Consequently, the Registrar of Companies has approved an official name change for public convenience and international compliance to read 'Lanka Alzheimer's Foundation', effective from 25 August 2010.

2. BASIS OF PERPARATION

2.1 Statement of compliance

The financial statements of the Foundation comprise the statement of financial position, statement of income and expenditure, statement of changes in fund, statement of cash flows and notes comprising other explanatory information. These statements are prepared in accordance with Sri Lanka Accounting Standard for Small and Medium-sized Entities (SLFRS for SMEs) laid down by Institute of Chartered Accountants of Sri Lanka.

2.2 Basis of measurement

The financial statements have been prepared on the historical cost conversion.

2.3 Functional and presentation currency

These financial statements are presented in Sri Lankan Rupees, which is the Foundation's functional currency.

2.4 Use of estimates and judgments

The preparation of financial statements in conformity with Sri Lanka Financial Reporting Standard for Small and Medium-sized Entities (SLFRS for SMEs) requires management to make judgments, estimates and assumptions that affect the application of accounting policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the result of which form the basis of making the judgment about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimates are revised if the revision affects only the financial year or in the period of the revision and future periods if the revision affects both current and future financial years.

3. SIGNIFICANT ACCOUNTING POLICIES

The accounting policies set out below have been applied consistently to all periods presented in these financial statements.

3.1 Property, plant and equipment

(i) Recognition and measurement

Items of property, plant and equipment are measured at cost less accumulated depreciation and accumulated impairment losses. Cost includes expenditure that is directly attributable to the acquisition bringing of the asset and the assets to its working condition.

An item of property, plant and equipment is derecognized upon disposal or when no future economic benefits are expected from its use. Gains and losses on disposal of an item of property, plant and equipment are determined by comparing the proceeds from disposal with the carrying amount of property, plant and equipment and are recognised net within surplus or deficit.

(ii) Subsequent expenditure

Subsequent expenditure on intangible assets is capitalized only when it increases the future economic benefits embodying in these assets. All other expenditure is expensed as incurred.

(iii) Depreciation

Depreciation is recognized in the income statement on a straight-line basis over the estimated useful lives of the assets. The estimated useful lives for the current and comparative periods are as follows:

Depreciation methods, useful lives and residual values are reviewed at each reporting date.

Depreciation will be started on asset month of acquired.

(iv) Impairment of non - financial assets

At each reporting date, property plant and equipment is reviewed to determine whether there is any indication of possible impairment, the recoverable amount of any affected asset (or group of related assets) is estimated and compared with its carrying amount. If the estimated recoverable amount is lower, the carrying amount is reduced to its estimated amount, and an impairment loss is recognized immediately in the statement of comprehensive income.

(v) Property, plant and equipment received as donations

Property, plant and equipment that is received directly as donations or endowments are debited to the property, plant and equipment account at fair value and a corresponding amount credited to a deferred income account. Such items thereafter be depreciated in accordance with this SL SoRP, while a corresponding amount is transferred from the deferred income to the statement of income and expenditure. In the statement of financial position, deferred income would be deducted from the net book value of the assets so that the carrying amount of the asset would be zero.

3. Significant accounting policies (Continued)

3.2 Basic financial instruments

The Foundation recognizes all financial instruments at fair value. The gain or losses from fair value is recognized in surplus or deficit during the period.

3.3 Cash and cash equivalents

Cash and cash equivalents are defined as cash in hand and demand deposits and short term highly liquid investments, readily convertible to known amount of cash and subject to insignificant risk of changes in value.

For the purpose of cash flow statement, cash and cash equivalents consist of cash in hand, call deposits and money market instruments.

Cash flow statement is reported based on indirect method.

3.4 Liabilities and provisions

Liabilities are recognised in the statement of financial position when there is a present obligation as a result of past events, the settlement of which is expected to result in an outflow of resources embodying economic benefits. A provision is recognised if, as a result of a past event, the Foundation has a present legal or constructive obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation.

3.5 Taxation

The Foundation is liable for income tax on its taxable income according to the provisions of the Inland Revenue Act No. 24 of 2017 and its subsequent amendments.

3.6 Income

All income is recognized on accrual basis.

3.7 Expenses

All expenditure incurred in the operations of the business and in maintaining the property plant and equipment assets in a state of efficiency have been charged to revenue arriving at the Foundation's surplus or deficit for the year.

3.8 Events occurring after the reporting date

All material post reporting date events have been considered and where appropriate adjustments or disclosures have been made in respective notes to the financial statements.

3.9 Commitments and contingencies

All capital commitments and contingencies are considered and necessary disclosures were made in the respective notes to the financial statements.

Commitments and contingent liabilities are disclosed in note 12 to the financial statements.

Clause 10 of the said agreement does not permit the leasee to sublet, mortgage or otherwise dispose or deal with their interest in the lease without the prior consent of the Land Commissioner.
